Occupational Safety & Health Technical Visit to Ngong Ping 360 Garage and Tung Chung Cable Car Terminal (TCT) Control Room

Introduction

Ngong Ping Cable Car is a tourist attraction featuring a spectacular 5.7km scenic bi-cable ropeway. It is the first of its kind in Hong Kong. The cable car journey begins from Tung Chung new town, overseeing the Tung Chung Bay after reaching the angle station on the Airport Island and turning about 60 degrees in the air towards the North Lantau Island. Ngong Ping 360 Limited is offering our members an opportunity to visit its Garage and the Tung Chung Cable Car Terminal Control Room. The visit is solely for members of the Association and it will provide a good opportunity for members to appreciate the operations of the suspended aerial system and its safety control features.
