Jarlway Xinxin Machinery Inc. was established in 2005. The company specializes in the research, development, design and manufacturing of tower cranes for sales and rental. It also engages in providing servicing, installation and maintenance. The factory is located in Guangzhou, Mainland China.

Hontrade Engineering Limited, a Hong Kong tower crane specialist, became the controlling holding company of Jarlway in 2010, and participated actively into its day to day management and operations. New models were soon developed, including the increasingly popular topless and luffing jib tower cranes. The Jarlway tower cranes exhibited during Bauma Shanghai 2010 met with great acclaim.
