Experience Sharing Workshop – online forum

"From Manager to Director, within the domain of Occupational Health and Safety"

While the registration of Safety Officer in practice is defined by law, how that a safety practitioner can be recognized as a safety professional is an issue now handled by the membership committee of HKOSHA. What is seldomly talked about is how and in what way that a safety professional whom had been in a managerial status for some years can further his/her career path to the Head/Director level. This experience sharing workshop is to cover series of related soft skills and practical experience.

Topics

- 1. When you are prepared to take a step further up on the career path, do you know what are the prerequisites of a Safety Director?
- 2. As a Safety Director candidate, DO you know what the Board of Directors want from you?
- 3. Do you know how to set up your Health and Safety Office?
- 4. While you are going to follow the legal requirements to set up your company health and safety management system, do you know the reasons behind? If not, what to follow?
- 5. When you are going to propose a safety management program the Company Management, what are the key issues for you to obtain their support?
- 6. Why that the workers do not follow your PPE program?
- 7. Are you going to do all the job by your own, or who else can help you out from the promoting your H&S programs?

The on-line workshops will be led by a team of senior figures of the HKOSHA via stories, case studies, group discussions, Q&A, etc.

Each topic will last 1-2 hours which is highly depends on the response of the participants.

The actual date and time for the workshops should rest with the team to decide.
